## Employer Paid Leave Registration

Once your business has been registered in Delaware Labor First, you will follow these steps to finish registration for Paid Leave and make your elections for applicable lines of coverage:

- 1. Divisions: This screen drives to Delaware Labor First lines of business. Select "Paid Leave" to access DPL services.
- 2. Paid Family Medical Leave: This screen describes the lines of coverage required. You are automatically enrolled in the Delaware Paid Leave plan (the 'public plan". You can apply to use a private plan (either a group PFML insurance policy or a self-insured plan) as an alternative. You can also voluntarily enroll for those lines of coverage you are not required to provide
- 3. Private Plan Details: If you have a private plan for the required lines of coverage, this screen allows you to provide the details of the private plan. All fields marked with an asterisk are required.
- 4. Registration Summary: Displays all fields and responses from the registration process. Review all responses for accuracy.
- 5. Confirmation: Confirmation of Division of Paid Leave lines and types of coverage.

**Quick Tip:** The right- hand side navigation always shows where you are in the process.
